This early twentieth-century bungalow is sited on a hilltop facing east onto Maryland Route 765. It is a one-and-a-half-story framed and weatherboarded structure that is set on a molded concrete foundation. It is two bays deep and seven bays long. The entrance is located at the center of the facade. There is a brick chimney situated at the center of the structure on the back face of the roof. The gable roof is extended forward to shelter a front porch. The porch roof is supported on Doric columns. The porch has been screened in. The upper story of the house is illuminated by a low shed dormer with small square windows. The other windows have six-over-one double-hung sash.





of PRINCE FREDERICK


