This late-nineteenth-century house was probably the original dwelling for the entire surrounding tract of land. The property has now been laid out and built up into a modern subdivision. The house faces west onto Calvert Towne Road. It has been heavily reworked. It sets on a new brick foundation. It is a two-story framed and weatherboarded cross-gable house. It has a gable roof and a central brick chimney. The house has a three-bay facade, with the central sidelighted and transomed doorway set into the advanced cross gable. There is a polygonal two-story bay on the south gable end. All of the six-over-six double-hung-sash windows are new. The original ones were probably two over two. Vinyl siding and louvred blinds replace the original elements.


