This house is sited facing south onto Maryland Route 231. It is set on a concrete-block foundation. It is a one-and-a-half-story framed and weatherboarded house oriented with its gable end toward the road. The three-bay facade is composed of a central door flanked by pairs of windows with six-over-six double-hung sash. A gable-roofed off-center screened-in porch shelters part of the facade. There are two small windows set into the gable end to provide light for the upper story. Additional lighting is provided by windows set into east- and west-facing cross-gables. The house has recently been sheathed with aluminum siding.






PRINCE FREDERICK
