This two-story framed and weatherboarded four-square house faces west onto Solomons Island Road. It is set onto a decoratively molded concrete-block foundation. A side-lighted off-center entrance is flanked on the south side by two bays of paired windows. The sash -- probably altered -- are one-over-one and double-hung. The ridge of the shingled hipped roof runs perpendicular to the facade and has a hipped dormer set into each face. A hipped one-story porch is set on Doric columns and shelters the facade. On the north end of the house, the porch extends into a one-story wing addition. Vinyl siding and louvred blinds are recent additions.


