These three identical dwellings face east onto Calvert Street. They are set on concrete block foundations, are constructed of wood framing and beveled weatherboards, and have gable roofs oriented with the gable ends toward the front. There are concrete-block stove flues on the north side of each house. Each dwelling is two rooms long and each facade is two bays wide. Windows have six-over-six double-hung sash. Each facade is sheltered by a gable-roofed screened-in porch, and each house has a one-bay wing added onto the south side.


