The one-story rear ell and shed provide access between the main part of the house and the two-story single-pen framed extension. The original siding has all been replaced with vertical wood siding. The altered window sash have a six-over-six double-hung pattern. The facade is sheltered by an original hipped-roof porch that is supported on Doric columns.


