This house is set back off C Street, and is oriented with its facade toward the east. It is a gable-fronted, one-story framed and weatherboarded bungalow with an exterior brick chimney built onto the south side of the house and six-over-six double-hung sash windows. Numerous additions include a rear shed, an enclosed hipped roof front porch, and a new flat-roofed screened-in front porch. The exposed rafter ends are a prominent visual element of this early twentieth-century structure.


