Built at the turn of the century, this house is a gable-fronted structure with a two-bay facade composed of a side door and a bay of paired windows. Original windows have two-over-two double-hung sash. The house is two rooms deep and has a central brick chimney. There is a hipped-roof one-story screened-in front porch and a one-story rear ell.


