This early twentieth-century store building faces west onto Solomons Island Road, at the corner of B Street. It is a two-story framed and weatherboarded structure. The gable roof is covered with decoratively molded sheet metal. The original building has a cross plan, and the structure was heated by way of interior ridgeline brick stove flues. Most of the original details have been replaced, and the original structure has been surrounded by numerous modern one-story additions.


