This turn-of-the-century dwelling faces east onto Sedwick Street at its intersection with B Street. It is a one-story framed and weatherboarded dwelling with a hipped roof. The ridge-line runs perpendicular to the facade. In form, the house is essentially a very long shotgun dwelling with a two-bay facade sheltered behind a hipped-roof screened-in porch. The original windows have two-over-two double-hung sash. The house was clearly built in at least two separate campaigns.


