This two-story gable-roofed single-pile framed and weather-boarded house faces west onto Sedwick Street. It has a three-bay facade and a side-passage-parlor plan. There is an interior gable-end brick stove flue. The house has a one-story rear shed and an enclosed hipped-roof front porch. The windows are glazed with two-over-two double-hung sash. The original siding has been replaced with asbestos shingles. This house dates to the turn of the century.


