This early twentieth-century gable-fronted bungalow has never been significantly changed. It faces east onto Calvert Street. Set on a concrete-faced foundation, it is a one-and-a-half story framed and weatherboarded dwelling with a three-bay central entrance facade and a two-bay-long form. A one-bay extension to the rear of the house is probably original. The window sash are six-over-six and double-hung, and the front doorway is sheltered by a gable-roofed stoop. There is an off-center interior brick chimney.


