This one-and-a-half-story framed and weatherboarded Vernacular Revival house faces west onto Solomons Island Road. The house is oriented with its gable end toward the street. There is an exterior brick chimney centered on the facade and the upper story of the house is illuminated by a long shed-roofed dormer on the south side of the house. Windows have altered one-over-one double-hung sash. Entrance is through a one-story gable-roofed advanced bay with a doorway embellished by an added classical pediment. Another recent addition is the one-story enclosed front porch.


