This three-bay framed and weatherboarded I-house faces west onto Solomons Island Road. Set on a brick foundation and sheltered by a gable roof, this house is distinguished by an advanced central bay. A brick chimney, built along one interior partition wall, is one of an original pair. The main entrance is sidelighted and transomed; the original windows are glazed with two-over-two double-hung sash. There is an original two-story ell and a modern one-story rear extension. The most prominent feature of this turn-of-the-century dwelling is the hipped-roof glazed front porch.
