This framed and weatherboarded gable-fronted bungalow faces north onto B Street at the intersection with Sedwick Street. This early twentieth-century structure is two bays long with a three-bay facade. The main entrance is centered in the gable end and sheltered by a gable roof supported on plain wooden brackets. The windows are glazed with two-over-two double-hung sash. There is a central ridgeline brick chimney. The house is set on concrete block piers.


