There is an exterior brick stove flue built onto the north gable end. The original sash have a two-over-two pattern, but most windows have been replaced. There is an original two-story rear ell, a later one-story rear ell, and a fairly recent one-story north wing. The front hipped-roof porch has been enclosed. The original siding has been replaced with asbestos shingles.


