This three-bay framed and weatherboarded gable-roofed I-house dates from the turn of the century. It faces west onto Calvert Street. The two original brick chimneys are built along the major interior partition walls. A front-facing gable is centered over the main entrance. There is a two-story rear ell that is visually connected to the house by a two-story polygonal bay on the south gable-end wall. The original windows are glazed with two-over-two double-hung sash. The gable ends of the main section of the house are covered with wood shingles cut in decorative patterns and illuminated through small triangular-topped windows. There is a one-story hipped-roof porch supported on Doric columns sheltering the west and south sides of the house.


