This two-bay-long framed and weatherboarded shotgun house faces south; it is located off Calvert Street. The structure has a one-bay gable-end entrance and two-over-two double-hung-sash windows. The rafter ends of the gable roof are exposed. A wide shed has been built onto the east side of the house, and a broad gable-roofed screened-in porch is situated across the south side of both the original structure and the added wing. This house dates to the early part of the twentieth century.
