This two-story framed and weatherboarded side-passage-parlor-plan house faces south onto Back Creek. It backs onto Point Lane. This house, originally built at the turn of the century, has been heavily remodeled. A brick chimney on the east gable end has been rebuilt. The windows have been replaced. An original one-and-a-half-story rear ell has been encased with a modern one-story rear ell. A new one-story screened-in porch shelters the facade and the east gable end of the house. The original siding has been replaced with a coat of stucco.
