This framed and weatherboarded three-bay I-house faces west toward Solomons Island Road. Sited close to the Narrows of Back Creek, it is not readily visible from the road. It is a gable-roofed structure with a front-facing gable centered over the main entrance. The window sash are one over one and double hung -- they are not original. There is a one-story hipped-roof porch sheltering the facade. An original two-story one-bay-long rear ell is extended by a two-story modern addition. No original chimneys survive. There is a new interior brick chimney built into the modern rear addition. The vinyl siding and shingle roofing of this structure are recent additions. Basically, this turn-of-the-century house has been heavily and unsympathetically renovated.


