This small one-story framed and weatherboarded dwelling faces south. It is set at the back of the Clairice Langley lot, is not visible from Solomons Island Road, and is oriented with its gable end overlooking the Narrows of Back Creek. Set on concrete blocks, this small structure has an asymmetrical three-bay facade with a side entrance and two windows. The sash are six-over-six and double-hung. There is an interior concrete-block stove flue. The rafter ends of the gable roof are exposed. The original siding is covered with asphalt paper. This structure dates to the early decades of this century.


