This two-story gable-fronted framed and weatherboarded structure faces west onto Solomons Island Road. It has a three-bay asymmetrical facade consisting of a sidelighted and transomed doorway and two windows. The house has a side-passage plan. The original windows have four-over-four double-hung sash. The first floor of the facade is sheltered by a hipped-roof front porch supported on plain Doric columns. The structure has two-story and one-story rear ells. Built as a dwelling, the building has been converted to commercial use in recent years. The original siding has been replaced with blue-painted asbestos shingles.


