This small framed and gable-roofed dwelling faces west. It is sited on the edge of the Narrows of Back Creek, at the back of a lot that fronts onto Solomons Island Road. It is a one-story two-bay dwelling with tarpaper sheathing and a concrete-block stove flue built onto the exterior of the north gable end. The windows are glazed with six-over-six double-hung sash. There is a rear shed addition. The front of the house is sheltered by a shed-roofed porch. This dwelling was built sometime during the middle of the twentieth century.


