This three-bay framed and weatherboarded I-house faces west onto Solomons Island Road. It has a gable roof pierced by a gable front-facing dormer and two interior brick gable-end chimneys. The windows are glazed with two-over-two double-hung sash. The one-story hipped-roof front porch has been recently enclosed. The early twentieth-century house has an original two-story ell and other one- and two-story rear additions. The original siding has been replaced with vinyl weatherboarding. Behind the house are located four small framed and sheathed outbuilding: a one-story one-room two-bay summer kitchen, a one-bay tool shed, a two-story bicycle-repair shop with a modern one-story wing, and a building for coal storage.


