This two-bay two-story framed and weatherboarded house faces east onto an overgrown lane. It's gable end faces north toward Charles Street. The house is distinguished by a centered and front-facing gable with a round-headed window. No chimneys or stove flues are visible. The first-story facade, which could provide indication of the building's form, is obscured by a one-story hipped-roof enclosed porch that shelters the east and north sides of the house. There is an original two-story two-bay rear ell. The original sash have two-over-two double-hung sash. There is also a rear one-story enclosed porch. The original siding has been replaced with asbestos shingles.


