This one-story framed and weatherboarded gable-fronted bungalow faces east onto an overgrown lane off Charles Streets. Its windows are glazed with single-pane double-hung sash and its three-bay facade is composed of a central doorway and two flanking windows. The dwelling is two or three rooms long. There is an interior brick chimney set off center into the south face of the gable roof. The facade is sheltered by a hipped-roof screened-in front porch. This house dates from the early twentieth century.
