**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Adams House is a two part, frame building consisting of a two bay section and a one bay section, both two storys. The walls are covered with asphalt siding. There is a porch across the facade with tin roof. It is of interest to note that the windows on the second story are the most outstanding features of the dwelling with 9/9 sash. They are considerably larger than those below or in the lower wing.

It is said that the building was originally located on the southeast corner of Maryland Route 314 & 313, and was part of three sections, the other two sections standing seperately within site of this house.


