The Holden House is a five bay 1 1/2 story frame dwelling which has served its purpose as a residence and is beginning to decay. It is a typical vernacular dwelling of the 19th Century, although very late for the form.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Holden House is located on the south side of Maryland Route 302, approximately four-tenths of a mile from the Templeville Road, west of Templeville, Caroline County. The house is a late nineteenth century structure in a badly deteriorated condition.

The one and one-half story structure is of frame construction with a shingle exterior. The main facade (north elevation) is five bays with 2/2 pane sash windows in the central and outer bays, and entrances in the other bays. The gable roof has two gable dormers on the north side and a small brick stack at the west end. The east gable end has a single attic window. The south elevation has a porch formed by a shed extension of the roof, and the west side of the porch is enclosed for a storage room. Under the porch there is exterior siding instead of the shingles. However, there is no evidence of earlier materials in the house.




