DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Cherry House is located on River Road approximately .2 mile from Harrington Road in the vicinity of Ridgely, Caroline County. It is a curious combination of a typical three bay house with a barn-like structure.

The main section is a two story, three bay frame house with a gable roof. It has central doorways on the two major facades, 2/2 pane sash windows on the other bays, and a one story porch on the south facade and a separate entrance porch on the east gable end.

Located to the southwest of this house is a large one and one-half story gambrel roof frame building. This building is connected to the main house by two structures with single pitch roofs. The barn-like building has an assortment of windows inserted in it, flat roof dormers at the secondary ridges of the gambrel roof, and ornamental shingles and trim on the upper section of the south end. This building has interior end brick chimney stacks.

Both structures of the Cherry House appear to be of the late nineteenth century. The combination of these structures probably developed from a functional reason, such as the use of the gambrel roof section as a work shop.


