Late 19th Century

Like the O'Neill House near Ridgely, this dwelling is a very typical late 19th Century two-story structure. One feature which it bears is a small horizontal window in its gables which is very common in this area of Caroline County. Liden's Venture, south of this dwelling, had such windows installed in the 1880's.

 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Former Liden House is located on the south side of the intersection of Melvin Road with its access road to Maryland Route 404 approximately one-half mile from Maryland Route 404, southeast of Andersontown, Caroline County. The structure is a late nineteenth century house.

The main section of the house is two stories and has a one and one-half story rear wing. It is of frame construction on a brick foundation and is presently covered with asphalt siding. The main facade (north elevation) is three bays with a central entrance. The entrance has a transom and sidelights. The other bays on the main facade and the two bays on the gable ends have 6/6 pane sash windows. The gable ends also have two horizontal attic windows per gable. The rear wing is three bays with a central entrance, 6/6 windows on the first story, and 3/3 windows in the half story. There is evidence of a one story full length porch on the east gable end and rear wing. The rear wing has an interior end brick chimney stack in its gable end.


