DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Lydia Dyer House is located on Fourth Street between Lincoln and High Streets. It is a small frame structure in very poor condition.

The building is composed of a three bay long, one and one-half story section with a one bay, one story wing. All of the windows of the first story have 6/6 sash. The dormer has 4/4 sash and in the gables are four pane casements. A brick chimney rises within the south gable. Its central entrance door has been replaced with a half glazed door of early 20th century date. The walls are covered with asbestos siding and the roof, which is half deteriorated is asphalt. The single dormer on the west side appears original and has good lines and some original details where the cornice returns on its face.

The interior consists of one room in each section with fragments of late 18th century woodwork. On the second story are two small rooms divided by a board partition. The stair has been altered to ascend from the wing, but originally it would have ascended from the one large room which had a fireplace adjacent.

STATEMENT OF SIGNIFICANCE

The Lydia Dyer House is an important survival of a small residence built in Denton during the first days of its existence. It may have been moved to its present location from elsewhere in the town but it appears to be the earliest dateable building in Denton. Future investigation into the matter may shed light onto its origin and owner.




