**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The small house on the southwest corner of 4th and Fountain Streets in Denton was moved to this site from the down town area of Denton. It is a three bay long, one and one-half story frame structure now upon a block foundation. The walls are covered with asphalt siding and there are porches on south, east and north sides of the building, the latter being screened. They are all of 20th century date. Its east facade is composed of a door with two flanking windows having 6/6 sash and louvered shutters. In the 'A' roof above are two chimneys defining the ends of the original section. On its north end is another small section, the same height as the older part, with one window on the first story and a dormer above which matches one of the two dormers in the older section. The latter windows have 4/2 sash except the center dormer which is larger and has 2/2 sash.

In the south gable are two four pane casements with a door below. On the north gable is one window with window and door below. The west side is the same as the east, but lacks a porch.

STATEMENT OF SIGNIFICANCE

From the evidence of the exterior, the house appears to date from around 1800, in which case it would be one of Denton's few early dwellings. It is a typical early vernacular building, although it seems smaller than most buildings of the period.


