**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

The Fred Mueller House is located on Substation Road approximately one quarter mile east of the intersection with Bates Road in the vicinity of Hickman, Caroline County. The owner does not want his property included in the county historic buildings survey.

The house is a five by two bay two story structure with a central hall plan. The main facade has 4/4 windows in the outer two bays on each side; a central doorway with round arch panels and a transom on the first story; an undersized window in the central bay of the second story, and a small horizontal window above it; and a full length one story porch supported by columns. The brick chimney on the west gable end is offset from the ridge towards the front of the house. Across the rear facade is a one story enclosed porch. A wide aluminum siding is currently on the exterior of the house.

Further inspection would be necessary to determine a date range for the house.


