STATEMENT OF SIGNIFICANCE

"The Nicholites first permanent place of worship was in a meeting house erected on the banks of what is still known as Quaker Meeting House Branch, near the site of the old colored school at Federalsburg. About 1817, the Nicholites were accepted as members of the Third Haven Meeting and generously transferred to this meeting their three meeting houses in Caroline County, namely: Center (near Preston), Tuckahoe Neck (near Denton), and North West Fork (now Pine Grove)."
