DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Sherman Council House is located on Maryland Route 313 approximately one and one-half miles south of Goldsboro. It is a late nineteenth century frame house in the country Victorian style.

The house consists of two sections irregularly attached to each other. The main section is two and one-half stories with a three bay main facade facing west. This facade has an entrance with transom in the north bay of the first story, and 4/4 pane sash windows with louvered shutters in the other bays. It has a high bracket cornice above which is a mansard roof with various ornamental shingles and three pediment dormers with arched windows and shutters. There is a full length, one story porch with elaborate bracket supports on the upper sections of the pilasters. The porch continues around the north side of this section to shelter the entrance into the north section.

The north section has a three bay facade with central doorway and one story, one bay entrance porch facing the north. Its roof projects upwards like a gable roof but levels off just below the height of the mansard roof, as shown in profile from the west facade. The roof on this west facade has a dormer and the ornamental shingles indential to those on the mansard roof, and also has a brick chimney stack protruding at the ridge of the roof. There is a small addition on the east side of this north section.

STATEMENT OF SIGNIFICANCE

The Sherman Council house is a good example of the rural Victorian style house in Caroline County. It is a rare example of a mansard roof being employed in a totally rural context, and the ornamental details in the roof, dormers, and porch brackets are well executed. The house is currently undergoing restoration by the owner.
