DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Commercial Building is located on the south side of Maryland Route 317, approximately four-tenths of a mile east of Dead End Road, west of Burrsville, Caroline County. The structure is presently used as a mechanics garage.

The building is a late 19th century frame and clapboard structure on a brick foundation. It is rectangular shaped with a gable end main facade (north elevation). The main facade has a central entrance, a tall 2/2 pane sash window to each side of the entrance, and a two pane window on the peak of the gable. The west side has two 6/6 pane sash windows with a concrete block exterior stack between them. The east facade has been altered through the insertion of a wide garage opening with a sliding door.


