DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Knotts Mill House or Elben's Mill House is located across the road and a little north of the former brick mill, near Layton Mill House. The original Mill House is a three part frame structure composed of a five bay long, two and one-half story section, a three bay long, one story section and an attached one bay one story summer kitchen.

The large section of the house is covered with red wood shingles and has white trim. It has a central door with transom and all windows have 6/6 sash (replacement). Within each gable is a brick chimney. There are two dormer windows on each side of the 'A' roof. The north side of the house has the same fenestration except, no central door.

To the east is a kitchen wing with leanto porch on the south (recent) and leanto enclosed wing on the north. The fenestration has been completely changed, but originally had a center door and two window. The summer kitchen has a cross passage between it and the kitchen.

The interior, as is evident from the exterior has a central stair with two rooms on each story plus the kitchen and room above. Off the kitchen is a pantry and bath, the latter being on a former porch. Most of the interior was remodeled in the 1960's, with the dining room fireplace being re-oriented to the kitchen and other minor changes. It does still retain the majority of its interior trim from the middle 19th century, including the stair which ascends between two walls and divided at the top. A small very narrow stair ascends from the second to the third floor.


