DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Fisher House is a large late 19th century frame dwelling built on the hill overlooking the Choptank River Bridge at "Pig Point". Although hidden behind wide porches and aluminum siding, the form of the old house is still discernible. The two facades, one on Market Street the other on First Street, are nearly identical, with an apparently 'L' planned house. It is of interest, however, that it was originally a 'T' plan with hyphen and summer kitchen, according to the old photograph.

Since the photo of 1906, extensive porches have been added on the Market and First Street sides, the summer kitchen has been removed and an extension has been built on the south side of the house.

STATEMENT OF SIGNIFICANCE

The Fisher House is an important late 19th century dwelling which has remained in the same location for ninety nine years. It was a good example of architecture in its day and continued to be improved throughout its long history.

Before the house was built, there was an earlier brick dwelling which burned. In 1879 Captain Robert R. Emerson bought the lot and according to tradition, he built the present house. In 1903 Mrs. Emerson sold the building to her brother Henry Clay Fisher. It later was acquired by his son Dr. P. Roland Fisher and remained in his widow's possession until 1960 when it was bequeathed to her niece, who is the present owner.
