DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Across the street from the Caroline County Courthouse stand the three story brick Law Building constructed around the first decade of this century. Its facade is five bays wide and it is seven bays deep. Finer brick is used on the facade than the sides. The first story of the facade has commercial windows, the eastern half being original and the western half being remodeled to resemble "colonial" design. In the center is the entrance to the building flanked by stubby columns which support the remains of a cornice which extended above the windows.

Above the cornice corner pilasters are visible, as are two pilasters flanking the central windows which extend into the cornice. Between storys is a decorative band of molded brickwork. All of the windows have segmental stone arches with paneled keystones. The sash have 2/1 panes. At the top of the third story is a shallow tin pediment having as its chief decoration the placard bearing the name "Law Building".

The sides and rear of the building are considerably less detailed as would be expected of a commercial building of this period.

STATEMENT OF SIGNIFICANCE

The Law Building is important architecturally as a good example of commercial architecture of the beginning of the 20th century. The entrance is reminiscent of the designs of Frank Furness of Philadelphia, although it has been stripped of its original finish at the top.

The structure is also important as the offices of many able attorneys who have served Caroline County since the turn of the century.
