The First Wesleyan Church on Market Street in Denton is a one story building with an extensively altered exterior.

The church is topped by a gable roof at the west end and a hip roof at the east end; the gable end may have been the original facade. Original features include the 2/2 sash windows on the rear and side elevations and the projecting pedimented entranceway with a transom, side lights and pilasters flanking modern doors.

The original wood finish of the facade and the southwest and southeast corners is now covered with cut stone. The 9/2 windows with aluminum shutters are also a later addition.




