One of the less architecturally distinguished commercial structures in Denton, this brick building is two stories high and six bays wide with a shed roof. The first story has large display windows with cornices and transom lights and a central recessed entranceway with a multi-paned transom light. The windows on the second floor have 2/2 sash and are set in segmental arched openings. Small recessed brick panels are set between the second story and the roof line.




