The Eveland Residence is located within the Tuckahoe State Park. The complex includes a barn and a storage building. Based upon the available information, the house was constructed in the first quarter of the 20th century.

The house is two bays wide, two bays deep with a hipped-roof, and a hipped-roof dormer. The main entry is enclosed within an asymmetrically roofed vestibule. The house is built upon a rusticated block foundation, it has two one-story shed-roof additions. The rear addition is a screened porch, the side addition is enclosed. The screened porch has a metal standing-seam roof, the other addition, has an asphalt roof. The principle block of the house has an asphalt roof. The house and all additions are covered with clapboard siding.

The barn is heavily covered in vegetation. It appears to be two stories high with a corrugated metal roof. It has a one story rusticated cement block addition. A building is covered in vertical siding, and artificial siding.

The storage shed has two sections. One section is cement block construction, the other is post and beam construction. The cement block component is covered in wooden siding, it functioned as a garage with two vehicular openings, one still maintains an overhead garage door, the overhead door for the other opening has failed. The post and beam section of the storage shed is greatly deteriorated.

These buildings lack the architectural qualities to qualify them for listing under Criterion C in the Maryland Register of Historic Properties. There is no known association with figures of local significance or broad patterns in Maryland history. Therefore they do not qualify for listing under Criteria A or B.


