Based on the photographs provides, the Williams House, 3666 Idlewild Court, Federalsburg, Caroline County, Maryland 21621, is a one-and-one-half story, 3-bay house with an asphalt shingle, gable roof. It is wood frame with weatherboard, a hipped porch roof and the windows are 1 over 1 double sash windows. The rafters extend below the roofline, which indicates that the house was built in the late nineteenth century. The house is a common rural type and does not possess any outstanding architectural features. Therefore, we agree is it not eligible for inclusion in the National Register of Historic Places.




