The Nagel farmhouse is a vernacular farm dwelling found frequently in Caroline and Dorchester Counties. It is composed of three small 1 1/2 story sections joined in the same manner as the Schmick House in Linchester. Its present facade indicates a central passage with rooms on each side and a kitchen behind the east room, set at a right angle thereto.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Nagel Farmhouse is located on Maryland Route 621, Agner Road approximately one and seven-tenths of a mile west of Maryland Route 16, east of American Corner, Caroline County. The house appears to have been built in the early nineteenth century.

The one and one-half story frame house consists of three sections. The main section has a three bay main (north) facade with a side entrance and a single gable dormer on the roof. The two windows have 6/9 sash. The east gable end has an exterior brick pyramid chimney stack. The west gable end has a two bay addition with 6/9 windows and a single dormer on the roof. A three bay long ell is constructed on the south side of the main section. It has a central entrance, a gable end chimney, and a full length screened in porch.
