"Brotherhood" is a rare survival of a form of dwelling used extensively throughout the Eastern Shore from the 18th Century well into the 19th Century. This log building is a single room cabin with loft. Since the fireplace is located outside the walls, the ladder to the loft is opposite. If other log structures remain in Caroline, they are covered with siding and plaster and have not been "discovered" yet!

 DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Fluharty Log House is located on Grove Road approximately one mile northwest of Grove. It is an early log house which has had its clapboard exterior covering stripped and it is used to display the personal collection of early tools, farm implements, minerals, artifacts and other items owned by Mr. Fluharty.

The log house is a single room structure with a loft. It has a central entrance on the north and south facades and a single window also on the north facade. The fireplace is located on the west gable end, built of brick and the rear side is partially exposed. The logs are saddle notched and the gable is covered with clapboard. The interior has a ladder staircase on the east wall. On the east side of the log house is a frame addition of one and one-half storys and three bays long. The addition has a porch and dormer on the north facade and is covered in an asbestos siding.

STATEMENT OF SIGNIFICANCE

The Fluharty log house is important as an example of a form of building which was not believed to have been widely used on the Eastern Shore. This example shows that there was some log building in Caroline County but the small scale of the house and lack of other examples suggests that it was infrequently used.






