From the exterior, this small 1 1/2 story frame dwelling appears to have been built around 1840. After examining the building in 1971, after a fire destroyed the back wing, it appears to have been built in two stages, since there was an interior wall which was an exterior wall. As the farm became more prosperous, the house grew to accommodate the needs of the family.

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Mastronardi House is located on the west side of Maryland Route 16 opposite the intersection with Gado Road, approximately 2.2 miles northeast of Maryland Route 331, northeast of Preston, Caroline County. The house is a mid-nineteenth century house that was burnt out in 1971.

The one and one-half story house is a five bay frame structure on a brick foundation. It has an 'A' roof, rebuilt exterior end brick chimney stacks, and three gable dormers on the roof. The main facade (east elevation) has a central entrance with sidelights and 6/6 pane sash windows in the other bays. There is a central rear wing with an enclosed porch on the south side. The exterior of the whole structure is clad in shingles.

The Mastronardi House shows the continuing popularity of the one and one-half story house in Caroline County. By the mid-nineteenth century, as shown by this example, the house form had adopted the five bay facade and the central stair hall floor plan.




