The Smithville Mill is a large industrial building for its location in the little populated area of Smithville. The walls are presently covered with sheetmetal. It was the site of a mill operated about 1840 by Samuel G. Smith. There was a saw mill and bark mill beside the brick grist mill. W. T. Hignut was the owner after Smith's ownership, until 1920. (McGrain, J.)

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Smithville Mill is located on the south side of Possum Hill Road, approximately one-eighth of a mile west of the Smithville Road. It is an early mill site, but the present mill structure was altered during the twentieth century and is presently unused and in a deteriorating state.

The present structure is an imposing frame and sheet metal industrial building on a block foundation. The main section is a long six bays by two bays with a three bay roofed loading dock on the north side. The south side has a wood and sheet metal addition built above the ground on brick pilaster supports. The wide gable roof has a two bay, one story central section built above it. On the east side is the mill wheel and machinery.

STATEMENT OF SIGNIFICANCE

The Smithville mill is a large imposing industrial building which is currently unused. An early mill was located on this site and it had continuously been the center for the agricultural processing of the farmers products until the mid-twentieth century, as shown by this excerpt from "The Molinography of Caroline County" by John McGrain:

"About 1840, Samuel G. Smith bought a mill previously operated by James Wright and before that by Issac and Levin Smith. It was a saw, grist, and bark mill built of brick. Both the Isler map of 1875 and the 1897 Saulsbury map showed W.T. Hignut Mill. The 1887 State directory listed as millers at Smithville both J.O. Brown and Son, and T.H. Thawley and Brother. The mill was operated in 1920 by William T. Hignutt (two T's), HCLN, p.285. The mill is still standing, much altered, on Possum Hill Road just east of the terminus of Smithville Road. Smithville Lake is formed by a dam across Marshyhope Creek and is one of the few ponds where a reflection of the mill may be photographed, in this instance, a not particularly attractive reflection of a mill covered with sheet metal. The mill is closed, the broad wheel unstrung and the sheet metal walls coming loose."


