DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

The Ridgely House is located on the southeast corner of the intersection of Railroad Street and Central Avenue in Ridgely, Caroline County. The architectural style of the house is a late nineteenth century Victorian influence. It is presently divided into apartments.

The two and one-half story structure is frame and clapboard on a brick foundation. Brick chimney stacks are located interior end on the gable roof. The main facade (west elevation) is five bays with a central entrance. There is an open pediment door frame with reeded pilaster strips surrounding the sidelights and transom. On the north side of the house is a first story porch within the wall of the house enclosed in glass. This porch extends along the two first story bays of the main facade. This porch has double half-pilasters at the corners, a balustrade in front of large twelve pane sections of window, and a four pane overlight for each window section. The main facade has 6/6 pane sash windows in the other bays and in a central gable on the roof, and in two gable dormers. The gable ends have two windows to a floor (except for the first story on the north side) and two attic windows. The south side has a porte-cochere. In the rear is a four bay long central wing.






