## DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

Prior to the erection of the present post office on the corner of Church and Depot Streets, there stood a truly superior board and batten Gothic Church. From the photo of an early post card, the church appears to have been similar to St. Paul's Hillsboro, except for the addition, in the corner of the building, of a tall tower with open bellfry and spire. The tower was divided horizontally into three storys, the upper story being the bellfry. From atop the square bellfry rose an octagonal spire with four pinnacles surrounding the base. In proportions it resembled the work of William Strickland at Emmanuel Church, New Castle.

The site of the Episcopal Church in Greensboro is important for the role the Episcopal church played in Caroline County. It is also of interest as the site of a fine Gothic Revival board and batten church. A building of this quality is indicative of the calibre of residents in Greensboro in the pre-Civil War period.
