SUMMARY:

The Manchester Bank building is an excellent example of the Colonial Revival style as depicted in a Carroll County small town. It was built in 1929 and designed by the Baltimore firm of Buckler and Fenhagen. In addition to its high style design, it contains several other impressive features for a rural bank such as the main floor furniture of Wallace Nutting and the ironwork by Samuel Yellin of Philadelphia.

DESCRIPTION:

The Manchester Bank building is located at the northwest corner of the square (Main and Westminster Streets) in Manchester. The lot had previously contained a brick commercial structure of the regional farmhouse style that had several commercial uses during its history including the location of the Hotel de Stick. The bank building was set back on both sides of its lot in contrast to the usual small town practice of building up along the sidewalk, in this instance reflecting a 20th century preference.

The bank structure is a one-story, three bay by four bay building with a tall Mansard roof. The main(east) facade is dominated by the central entrance with classical style details including a door frame with a large keystone, architrave, and dentil cornice. The entrance is flanked by pilasters that rise to the dentil cornice of the building and large dentilled segmental arch rises in front of the Mansard roof with an entablature inscribed "THE MANCHESTER BANK 1899--1929." Small windows (two panes wide in five rows) are in the other two bays of the main facade. The north and south facades have large windows in each bay with architrave and keystones. The Mansard roof is covered in slate.

A booklet entitled the Manchester Bank, Manchester, Maryland that was published for the bank's dedication describes the building in the following manner: "Its exterior walls are of brick and stone, and specially burned over-sized bricks have been used, which in size, color, and jointing, closely approximate brickwork of the period of the architecture(Georgian).

"The construction of the building is fireproof. The floors and stairs are supported by reinforced concrete slabs, the window frames and sash are of steel, and the slate roof rests on gypsum slabs in turn supported by steel trusses. Only for interior trim and furniture has wood been used.

"In designing the various rooms in the building an effort was made to keep the interior architecture consistent in style with the exterior, and this thought has governed as well, the selection of furniture and draperies and the design of the hardware.

"The equipment of the Bank is of the most modern type. The vault is protected by the latest devices, including complete electrical protection, which extends also to the various parts of the working space.

The Bank counter has the low rail instead of the old high screen, and the metal counter back of the rail has complete working equipment. The marble in the counter is Italian Rosato and the floor alternate squares of Champville and Belgian Black.

Description

"The iron work in the Banking room was done by Samuel Yelling of Philadelphia, probably the leader of his field in the country. He was awarded a few year ago, the Gold Medal of the A.I.A. for craftsmanship, and it is felt that his work in this building measures up to his very high standard.

"Mr. Wallace Nutting, who made the furniture for the Main floor, is one of the best authorities on early American Furniture, and the author of numerous books on the subject. His furniture is carefully copies from old pieces by skilled craftsmen.

"The furniture in the Directors' room and Basement Lobby is also copied from old examples and was made by Mr. John M. Bair, of Abbottstown, Pa.

"The following is a partial list of the contractors and sub-contractors for this building and equipment. They all showed an unusual interest and desire to cooperate with each other in their work. General Building Contractor: Lacchi Construction Company, Baltimore; Plumbing and Heating: Westminster Hardware Company; Electric Wiring: R.E.S. Swam & Company, Hanover, Pa.; Ironwork in Banking Room: Samuel Yellin, Philadelphia, Pa.; Valut: Diebold Safe & Lock Company, Canton, Ohio; Metal Counters and Equipment: Jamestown Metal Equipment Company, Jamestown, N.Y.; Wood and Mastic Floors: J. M. Adams Company, Baltimore; Exterior Stonework: David M. Andrew Company, Baltimore; Marble Work: French and Stevens, Washington, D.C.; Furniture: Wallace Nutting, John M. Bair; Lighting Fixtures: Blumenthal-Kahn Electric Company, Baltimore; and Burglar Alarm: O.B. McClintock Company, Minneapolis, Minn."

SUMMARY:

The Manchester Bank building is an excellent example of the Colonial Revival style as used in Carroll County for a commercial structure. It was designed by Buckler and Fenhagen of Baltimore and built in 1929. The building not only represents the high style architectural characteristics of the period, but also portrays the prominence of the bank within the community.

HISTORY:

The Manchester Bank was founded in 1899 as "The Manchester Bank of Carroll County." It purchased the Shower Building at the northeast corner of the square in Manchester and operated a banking facility out of the northwest corner of this structure. In 1928, its Board decided to build a new bank building and purchased the lot at the northwest corner of the square. The Manchester Bank operated out of this facility until the 1970s when the corporation merged with the Carroll County Bank and Trust Company. Carroll County Bank still operates its branch out of this building.


